PROVISION

宿泊約款

Article 1. Scope of Application

- 1. Contracts for Accommodation and the related agreements to be entered into between the Guest and the Hotel shall be subject to these Terms and Conditions. And any particulars not provided for herein shall be governed by laws and regulations and generally accepted practices.
- 2. Notwithstanding this preceding paragraph, the Hotel shall take precedence this special contract provisions these Terms and Conditions, insofar as such special contract does not violate laws and regulations and generally accepted practices.

Article 2. Breaches of Basic Compliance

The Guest who intends to make an application for an Accommodation contracts with the Hotel shall notify the Hotel of the following particulars.

- (1) Name of the Guest(s);
- (2) Date of accommodation and estimated time of arrival;
- (3) Accommodation Charges
- (4) Other particulars deemed to be necessary by the Hotel

Article 3. Registration

The Guest shall register the following particulars at the front desk of the Hotel on the day of accommodation:

- (1) Name, age, sex, address and occupation of the Guest(s);
- (2) Except Japanese, nationality, passport number, port and date of Entry in Japan.
- (3) Date and estimated time of departure; and
- (4) Other particulars deemed necessary by this Hotel.

Article 4. Refusal of Accommodation Contracts

The Hotel may not accept the conclusion of an Accommodation Contract under any of the following cases:

- (1) When the application for accommodation does not conform with the provision of these Terms and Conditions;
- (2) When the Hotel is fully booked and no room is available;
- (3) When the Guest seeking accommodation is deemed liable to conduct himself in a manner that will contravene the laws or act against the public order or good morals in regard to his accommodation;
- (4) When the Guest is a member of any designated organized crime syndicate or concerned with such, and / or any other anti-social forces (hereinafter the Crime Syndicate etc.), as established by the Act for the Prevention of Wrongful Acts by Members of Organized Crime Groups (enforced on March 1, 1992);
- (5) When the Guest is a member of organizations whose business is controlled by the Crime Syndicates or similar parties;
- (6) When the Guest is a member of organizations whose board member(s) belong to the Crime Syndicate or similar parties;
- (7) When the Guest is deemed likely to behave in a manner that will disturb other Guests;
- (8) When the Guest commits acts of violence, intimidation, blackmail, threatening behavior, and / or requests the Hotel to assume an unreasonable burden, or has behaved in the same manner in the past, towards the Hotel's facilities and / or the staff;
- (9) When the Guest seeking accommodation can be clearly detected to be carrying an infectious disease;
- (10) When the Hotel is unable to provide accommodation due to natural calamities, malfunction of facilities and / or other unavoidable causes;
- (11) When the Guest is deemed liable to conduct and / or have conducted himself in a manner that creates a disturbance which annoys other guests such as a highly intoxicated.

Article 5. Clarification of Name etc.

When the Hotel has accepted a request for accommodation in advance of the day of occupancy (hereinafter called "the request for accommodation reservation"), it may request the person making the reservation to clarify the following particulars, within designated period.

(1) Name, sex, nationality, address, and occupation of the person occupying

the accommodation.

(2) Other particulars deemed necessary by the Hotel.

Article 6. Occupancy hours of Guest Rooms

- 1. The guest can use the guest room of the hotel until the time specified by the hotel, unless otherwise specified in the accommodation plan. However, if you stay consecutively, you can use it all day except for the arrival and departure days.
- 2. Notwithstanding the provisions of the preceding Paragraph, the Hotel may allow the Guest to use the guest room outside the hours stipulated in the same Paragraph. In this case, the hotel will charge an additional charge separately stipulated. Please inquire at the front desk for details.

Check-in 16:00-19:00. (Please be sure to contact us if you will be arriving after 19:00.) Check-out 10:00

Article 7. Payment of Bills

Payment of bills shall be made in Japanese currency, traveler's checks and, or coupons recognized by the Hotel at the front desk of the Hotel, at the time of the guest's arrival or when requested by the Hotel. However, the Hotel cannot accept personal checks.

Article 8. Rejection of Continued Occupancy

The Hotel may reject the continued occupancy of the room, even for the period accepted, in the following cases.

- (1) When it comes under clauses 3 to 11 of article 4.
- (2) When the guest does not observe the rules stated in previous articles.

Article 9. Responsibility on Accommodation

1. The responsibility of the Hotel concerning accommodation shall start from the time the Guest registers at the front desk or when he enters his room, whichever is the earlier, and terminates at the time he leaves his room to depart.

- 2. When the Guest can no longer be accommodated due to reasons for which the Hotel is responsible, the Hotel shall arrange to secure accommodation of the same or similar standard facilities elsewhere for the Guest, excepting cases of natural calamities, and other causes making its observance difficult. In such a case, there shall be no charge to the Guest for the accommodation at the Hotel for the day.
- 3. The Hotel takes no responsibility to the accident which is occurred by the Guest's taking no notice of Contracts for Accommodation.

Article 10. Governing Language

In addition to Japanese, this agreement may be written in other languages such as English, Chinese, Korean, etc. However, if there is a discrepancy between the two texts of the agreement, the Japanese version shall prevail in all respects. shall be

Article 11. Observance of Use regulations

The Guest shall observe the Use Regulations established by the Hotel which are posted within the premise.

Article 12. Cancellation of Reservation

- 1. When the person making the reservation cancels the whole or a part of the reservation made, the Guest shall pay to the Hotel cancellation charges listed in Table 1.
- 2. In the case when the Guest does not appear by 10 p.m. of the accommodation date (1 hour after the expected time of arrival if the Hotel is notified of it) without an advance notice, the Hotel may regard the Accommodation Contract as being cancelled by the Hotel.

Article 13. Liability of the Guest

The Guest shall compensate the Hotel for the damage caused through intention or negligence of the Guest.

Article 14. Liability in Regard to Parking

The Hotel shall not be liable for the custody of the vehicle of the Guest when the Guest utilizes the parking lot that the Hotel contracts, at it shall be regarded that the Hotel simply offers the space for parking whether the key of the vehicle has been deposited to the Hotel or not. However, the Hotel shall compensate the Guest for the damage caused through intention or negligence on the part of the Hotel in regard to the contract of the parking lot.

Article 15. Disclaimer

The Guest shall be liable for any use of computer communication services from within the Hotel. The Hotel will not accept any responsibility for any possible damage that may be caused by a systems failure or any other reasons while the computer communication services are being used. In addition, the Guest may be required to compensate the Hotel and third parties for any possible damage caused by acts that are judged to be inappropriate use of our computer communication system
